If an existing system is proposed to be used, information shall be provided as to the present capacity of the system based upon the prior design approval by the Board of Health, or if such information is not available, then the present capacity of the system as calculated in accordance with current applicable regulations upon the basis of the design and size of the existing system.

If a new system or an alteration of an existing system is proposed, the following shall be set forth on the plan:

- (a) soil log data, soil test data, soil class rating determinations and ground water data, with elevations as to each; and
- (b) calculations for sizing component parts of the proposed new or altered system.

6. In the case of a Site Plan, twelve (12) copies of the Architect's plans for any building.
